
Dear Mesdames and Messrs.:

Pursuant to C.G.S. Section 3-37(b), as amended by Public Act 10-95, please find attached the monthly report providing certain information regarding the State's cash position and bonding.

The report for November reflects an adequate overall cash balance. The common cash pool component, however, declined during November and December, consistent with seasonal patterns. As reported last month, beginning December 1, 2011 we temporarily transferred bond proceeds to and from the common cash pool to address mismatches in the timing of receipts and disbursements. The temporary transfers were conducted in accordance with a formal and structured process that is part of the State's longstanding and sanctioned practice for managing fluctuations in the State's flow of cash to and from separate funds.
